The **World Mediation Forum (WMF)** is an international non-profit organization serving mediators from all continents, grounded in interdisciplinarity.

The mission of the WMF is to develop and exchange knowledge, information, and skills in all areas of mediation, particularly through the international conferences it has regularly organized for more than 20 years (2003 in Argentina, 2005 in Switzerland, 2007 in Israel, 2009 in Venezuela, 2012 in Spain, 2017 in Quebec, 2019 in Luxembourg, 2022 in Portugal - virtual, and 2024 in Brazil).

The **XIII Conference of the World Mediation Forum** will focus on the theme: **“Cultures of mediation and mediation as a transformative culture.”**

Within this overarching theme, the conference will address mediation in a wide range of fields: justice, universities, schools, companies, NGOs, sports and leisure organizations, religious contexts, healthcare systems, neighborhoods, municipalities, and more. It will therefore cover more traditional topics alongside questions concerning the prohibitions and limits of mediation practice, restorative justice, therapeutic justice, transitional justice, and transformative justice. The Conference will include theoretical thematic panels and panels presenting research findings, as well as more practical workshops and specific training sessions for particular groups.

Mediation and restorative justice tend to be defined narrowly and broadly – both as a process and as a practical philosophy of dispute resolution &/or conflict management. Confirmed Speakers

Pilar Del Río

Journalist, writer, translator, and President of the José Saramago Foundation. She began her career as a journalist at the Seville radio station La Voz del Guadalquivir and at the magazine Triunfo, later working for Televisión Española, Canal Sur, and Cadena SER. In 1986, reading the novel Baltasar and Blimunda moved her so deeply that she felt the need to meet its author and future husband, José Saramago, whose translator she became, rendering numerous works by the Nobel Prize in Literature into Spanish. She remains firmly committed to disseminating the moral and ethical principles that the Portuguese author expressed in his work.



Yves Cartuyvels

Jurist, philosopher, and criminologist, Yves Cartuyvels conducts research at the intersection of these three disciplines, combining theoretical approaches with empirical research. Academic Director of the Certificate in Local, School, Penal, and Healthcare Mediation (MLSPSS) at UCLouvain (Belgium). Emeritus Professor at UCLouvain Saint-Louis Bruxelles.



Jose Luis de La Cuesta

Professor of Criminal Law. President of the Honorary Committee of the Basque Institute of Criminology (UPV/EHU). Honorary President of the International Association of Penal Law (AIDP-IAPL). Former President of the Basque Council for the Participation of Victims of Terrorism (2010–2026).



David Moore

President of the Australian Association for Restorative Justice. He taught politics and history at the University of Melbourne and later at Charles Sturt University, where he coordinated justice studies and launched pilot programmes using group conferencing in the justice and education systems. After working in the Queensland Department of the Premier, David co-founded Transformative Justice Australia in 1995 and taught restorative practices in Australia, North America, Norway and the United Kingdom, while also providing conflict management services to Australian organizations. Since the early 2000s, he has worked as an independent facilitator, trainer and consultant in conflict management and constructive communication.



Invited Trainers



Marie Keenan

Professor Emerita (RTA) at the School of Social Policy, Social Work and Social Justice, University College Dublin. She is a criminologist, restorative justice practitioner, forensic psychotherapist, and registered social worker. She served as clinical and restorative justice consultant on *The Meeting*, an award-winning feature film on sexual violence and restorative justice, based on a true story.



Ivo Aertsen

Professor Emeritus of Criminology at the University of Leuven, Belgium, and actively involved in education and training in mediation and restorative justice. He has coordinated a number of European research projects in the field of restorative justice and has served as an expert for various international institutions. His research focuses on restorative justice in relation to institutional violence and environmental crime, as well as on restorative cities.



Alberto Olalde

Professor of Social Work at the UPV/EHU and member of the Laboratory of Theory and Practice of Restorative Justice. He has professional experience as a social worker from 1998 to 2011 in residential care for incarcerated people and young people in conflict with the law, as well as a mediator and facilitator in public family mediation and restorative justice services of the Basque Government. He has experience facilitating restorative processes in cases involving terrorism and sexual abuse in religious institutions.



Idoia Igartua Iaraudogoitia

Professor in the Department of Criminal Law at the UPV/EHU and member of the Laboratory of Theory and Practice of Restorative Justice. She has extensive professional experience in supporting victims of crime and facilitating restorative processes, having worked as a lawyer in the Basque Government's Justice Cooperation Services for more than two decades.



María del Mar Puga

Graduate in Law. Master's Degree in Conflict Management and Resolution: Mediation from the University of Barcelona. She has worked for ten years as a mediator in the public family mediation and restorative justice services of the Basque and Catalan Governments. She is a member of the Laboratory of Theory and Practice of Restorative Justice at the Basque Institute of Criminology.



Leticia Trombini Vidotto

PhD in Psychology from the University of São Paulo (USP). Member of the Research Laboratory in Dialogical and Collaborative Practices (DIALOG) and of the Laboratory of Theory and Practice of Restorative Justice at the Basque Institute of Criminology. She has practical and research experience in conflict transformation, social constructionism, Single-Session Narrative Therapy, and restorative justice.



Olivier Chambert-Loir

Mediator and certified trainer in transformative mediation. Fellow and Board Member of the ISCT – Institute for the Study of Conflict Transformation, United States. President of the AATC – Association for a Transformative Approach to Conflict, France and the French-speaking world.
